



Notice of Race A-Class Event May

Organized by Dutch A-division Catamarans Association (DACA) and Catamaran Vereniging Hellecat from Saturday May 4th until Sunday May 5th, 2024 location: Haringvliet, the Netherlands

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1 RULES

- **1.1** The event is governed by the rules as defined in *The Racing Rules of Sailing (RRS)*.
- **1.2** The 'Rules for Championships Sailing, Windsurfing and Kiteboarding'.
- **1.3** A-Cat class rules will apply for this event.
- **1.4** If there is a conflict between languages the text in the English language will take precedence.
- **1.5** Every person on board who has his domicile in the Netherlands shall have the appropriate license and if applied for class membership.

2 SAILING INSTRUCTIONS

2.1 The sailing instructions will be available not later than 1st of May 2024 on the website of DACA (www.a-catned.nl) and on DACA Facebook (https://www.facebook.com/dutchaclass)

3 COMMUNICATION

- 3.4 [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 ELIGIBILITY AND ENTRY

- **4.1** The event is open to A-Cat foiling and classic.
- **4.2** Spare
- 4.3 Classes are defined as follows: A-Class
- **4.4** Boats may enter the event by registering online only before May 3rd 2024 at 24:00 hours at www.a-catned.nl of https://www.facebook.com/dutchaclass





4.5 Only online registration will be accepted.

To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.

This can only be done online (by bank transfer)

5 FEES

5.1 Entry fees are as follows:

A-CAT Classic and Foiling; early entry until the 23rd of April 24:00 hrs € 80, otherwise € 110

Sailors dinner on Saturday is included in entry fee.

- 5.2 The race committee has the right to cancel the event when the registered number of boats is less than 10. If so, this will be announced not later than May 3rd, 2024. In case the race committee decided to cancel the event based on registered sailors, all participants will receive a refund.

9.2 Boats can be parked at the club a weekend before the event, free of charge. Dates and numbers of racing:

- **9.3** Number of races for A-Class is 8, races scheduled per day is 4, with a maximum of 5 races per day.
- **9.4** On the last day of the regatta no warning signal will be made after 16:00 hrs.

10 EQUIPMENT INSPECTION

10.1 Boats may be inspected at any time. There is no event measurement

11 CLOTHING AND EQUIPMENT

All sailors shall minimum wear a wet or dry suit and lifejacket. In addition, all foiling boats are required to wear a helmet. When not wearing / available at inspection, the race committee can give a DSQ for one race a day.





12 VENUE

- **12.1** The race office is located at the following address, Duinweg 11B, Hellevoetsluis, The Netherlands. No car parking is allowed near the clubhouse, only at the large parking area.
- 12.2 Transport of the boat from the parking lot to the beach is allowed under the condition that once the trailer is unhooked the car needs to go back immediately to the parking lot.
- 12.3 Boats can only be brought to the venue on the listed dates in the schedule. Outside these moments, boats must be parked at the large parking area and not in front of the clubhouse. Requests for boat parking on weeks-day, can be done by contacting the A-Cat Class organization.
- **12.4** NoR Addendum A shows the plan of the event venue.
- **12.5** NoR Addendum B shows the location of the racing areas.

COURSES

12.6 The courses to be sailed will be Upwind Downwind. Nor Addendum C

PENALTY SYSTEM

12.7 For the all class(es) RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

13 SCORING

- **13.1** Four races are required to be completed to constitute a class event.
- **13.2** (a) When 5 races have been completed, a boat's series score will be the total of her best 4 race scores.
- **13.3** (b) When 8 races have been completed, a boat's series score will be the total of her best 6 race scores.

19 DATA PROTECTION

- **19.1** By participating in this event, competitors automatically grant to the organizing authority and the event sponsors the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

20 RISK STATEMENT

- 20.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
- **20.2** The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

21 INSURANCE

21.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of Euro 1.500.000 or the equivalent per incident.


